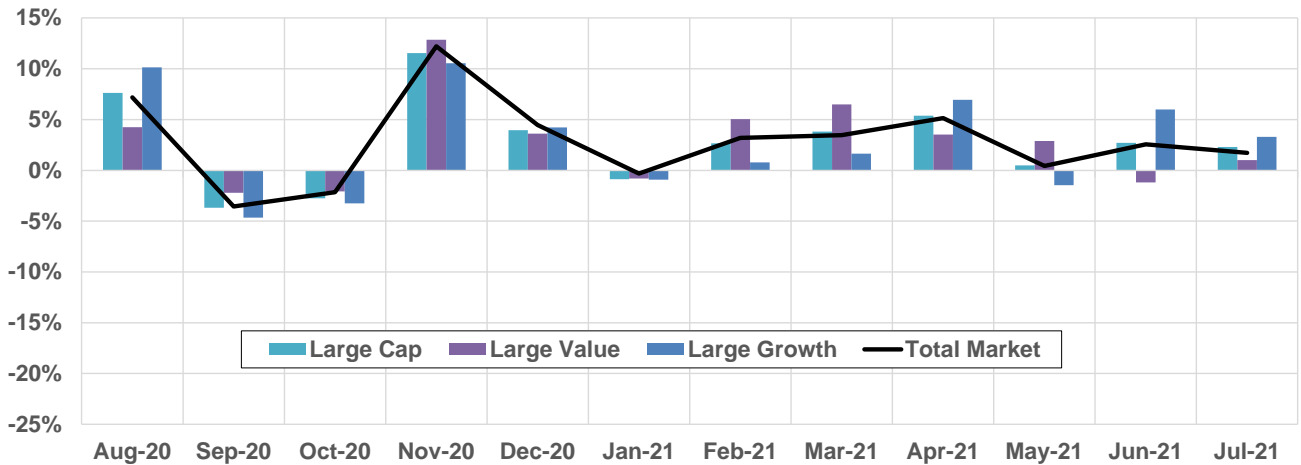

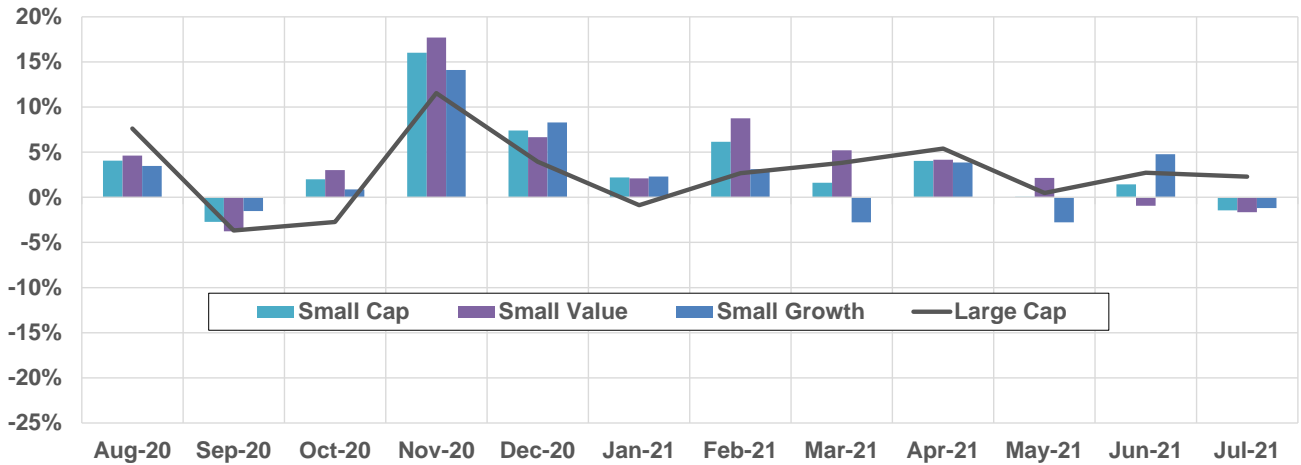

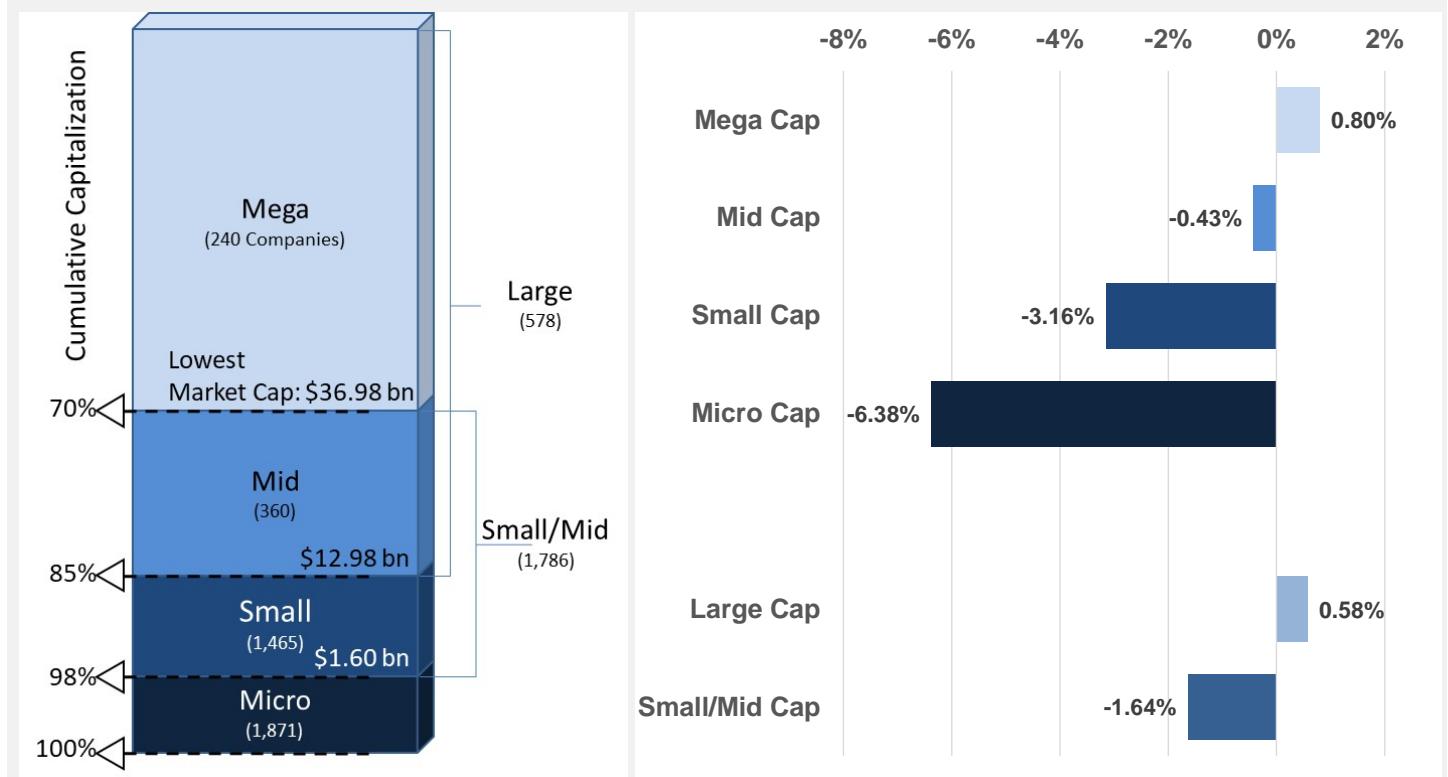

## CRSP Breakpoints (June 2021 Ranking)

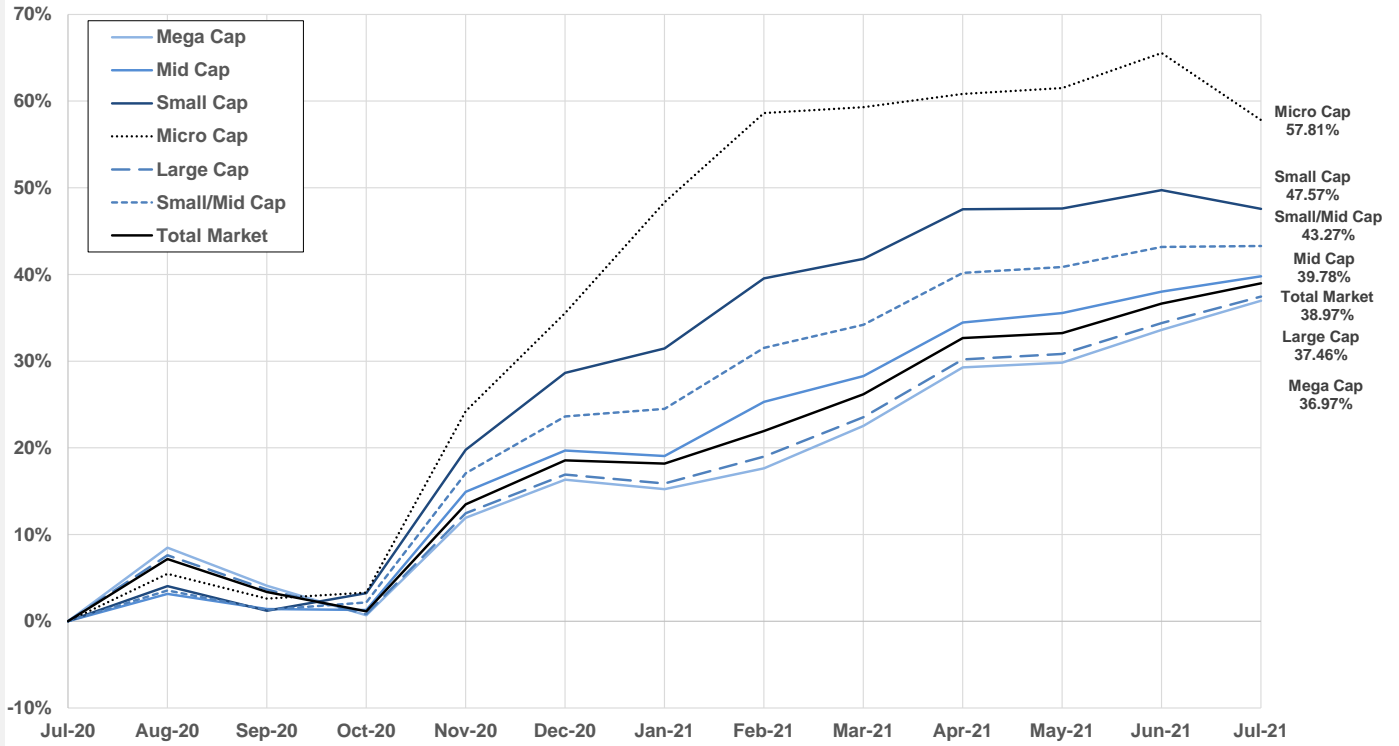
## July 2021: Performance Relative to Total Market



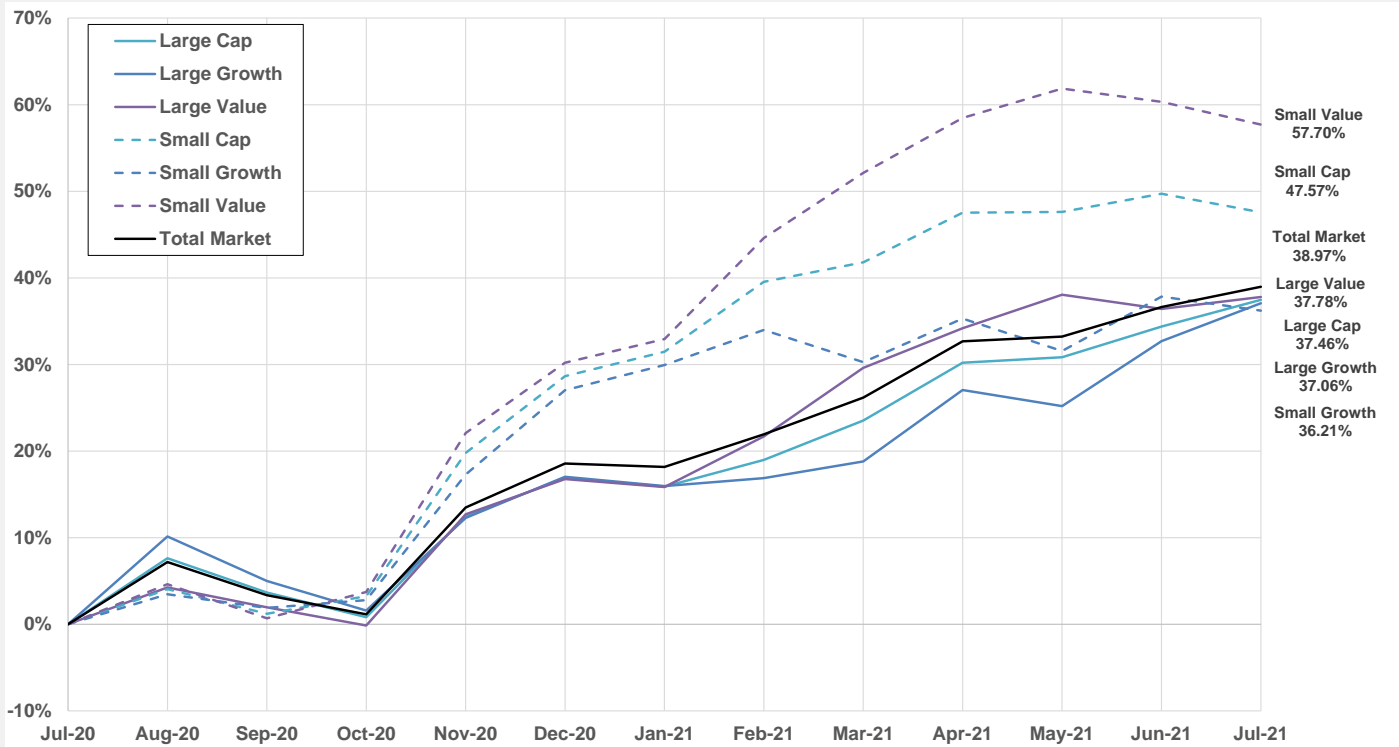

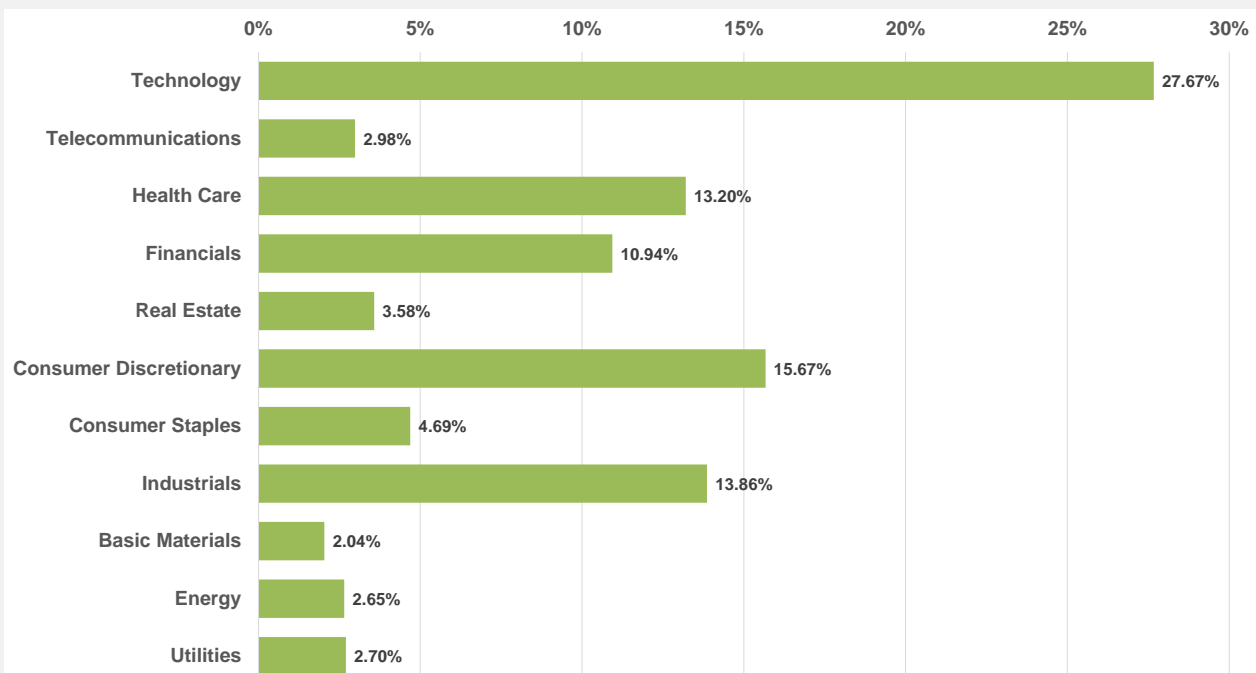
