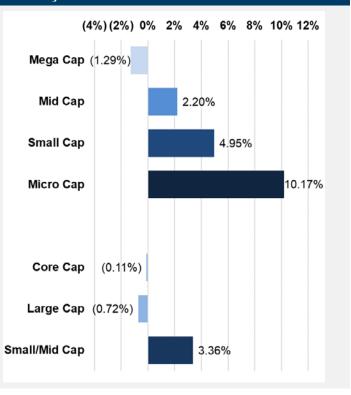

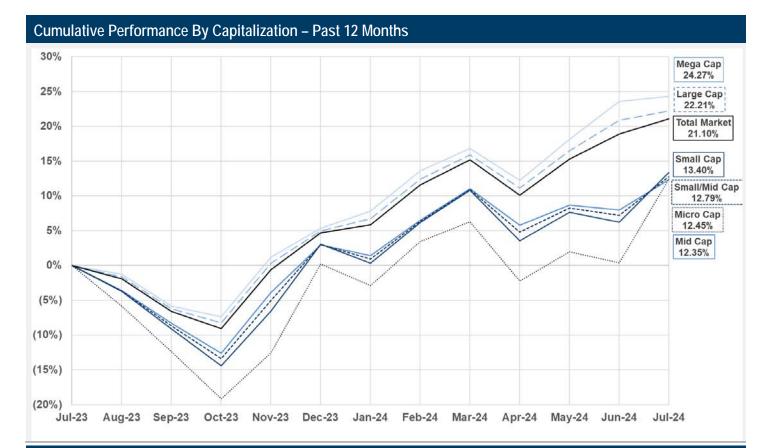


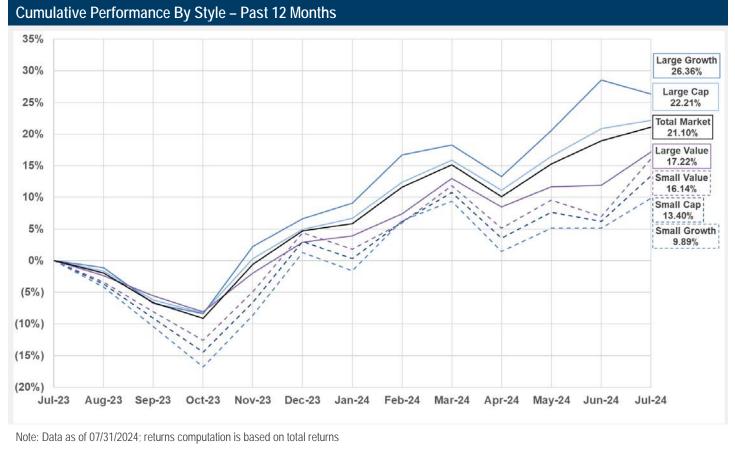
July 2024: Returns Relative to Total Market

CRSP Market Cap Indexes Sector Allocation

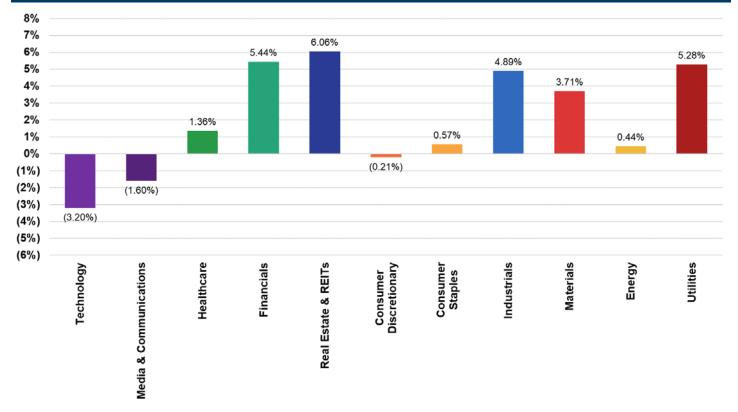

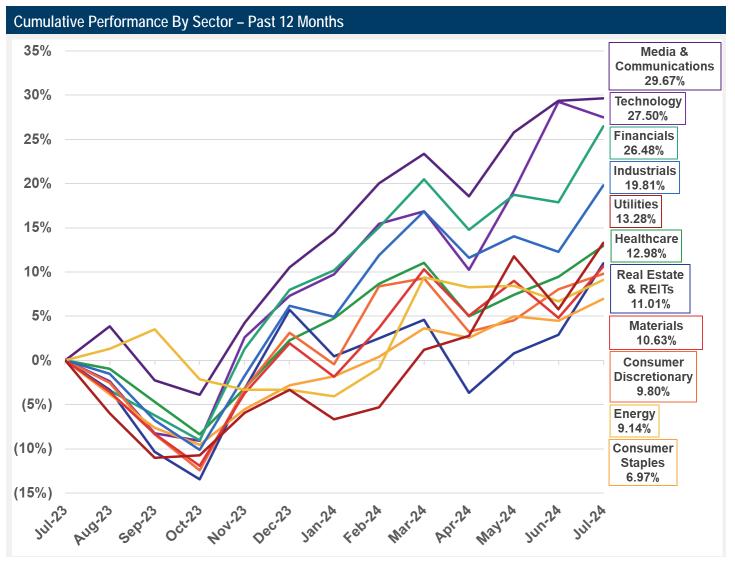

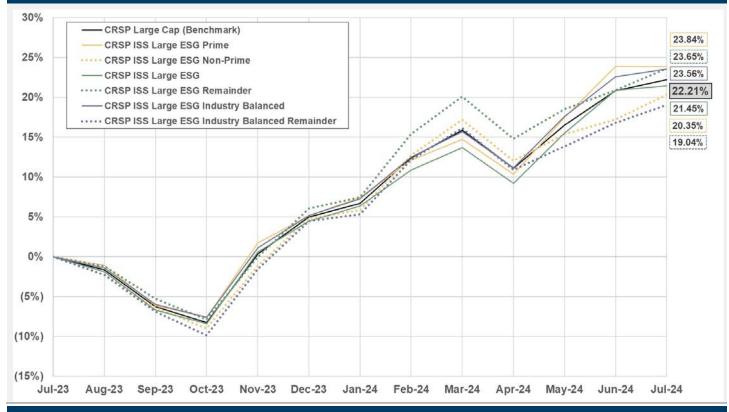

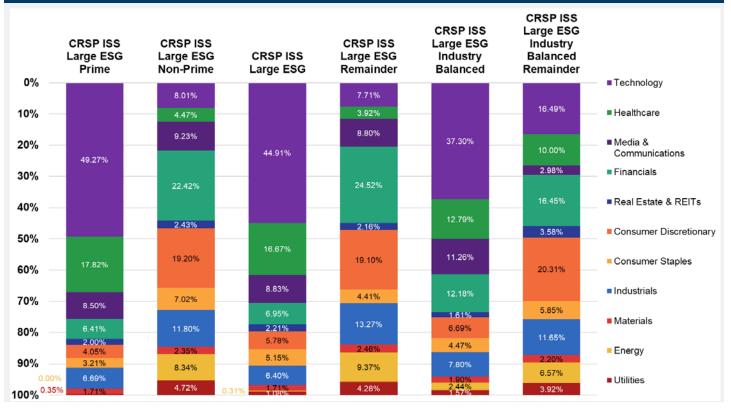

APPENDIX – DEFINITIONS

Average Company: Average float-adjusted market capitalization of a company included in the index

Count: Number of companies contained within the index. A single company may have multiple securities associated with it. Counts for individual cap indexes may not add up to counts for the combined cap index due to banding and migration. For example, number of companies in Mega Cap Index plus number of companies in Mid Cap Index may not add up to number of companies in Large Cap. For more information regarding banding and migration please refer to the <u>CRSP</u> <u>Methodology</u>.

Float-Adjusted Market Cap: Represents the float-adjusted market capitalization of a company as described in the <u>CRSP</u> <u>Methodology</u>.
