# CRSP U.S. TREASURY RELEASE NOTES

OCTOBER 2024 MONTHLY UPDATE

## IMPORTANT: DATA SOURCE CHANGE FOR US TREASURY PRODUCT

CRSP has changed data sources for its US Treasury product from CME's GovPX to ICE Continuous Evaluated Pricing (CEP) beginning September 3, 2024. The October release (with data ending September 30, 2024) of the CRSP US Treasury product will be CRSP's first release utilizing the new ICE data source. Only those data beginning September 3 will be impacted as the sources for historical data have not changed. As a courtesy to our clients that would like continuity of data source through the third quarter of 2024, we will provide a separate release of the US Treasury product (with data ending September 30, 2024) that will use the GovPX source.

While the ICE treasury quotes are continuously evaluated, CRSP uses a 4pm ET snapshot of the quotes for our US Treasury product. The ICE evaluation process is a rules-based process that utilizes standard valuation techniques and maximizes the use of relevant observable inputs. Evaluation inputs include, but are not limited to, executed trades and broker quotes. Incoming market data is enriched through the ICE pricing application to cover between spread, yield and/or price information as appropriate to allow for extrapolation across a range of related securities. Settlement dates are T+1 for all U.S. Treasury securities which will slightly impact the data representation relative to the GovPX data source. Also, there will be small differences in the quotes produced by the two evaluation processes (GovPX and ICE) which ultimately impact yields, duration and returns. **Details with some examples from the July data cut are in the following paragraphs.**

## FEWER WHEN ISSUED QUOTES

July data has 14 securities where ICE CEP starting quote dates are later than CME Govpx by 1 – 4 trading days. These dates are all before the issue date so no non-'when issued' quotes are missing from ICE data.

## TREASURY BILLS VALUED AT \$100 THE DAY PRIOR TO MATURITY

Because of the t+1 settlement date, bills will now have bid and ask = \$100 on trading day before maturity date.

## SOME NON-TREASURY BILL QUOTES UNAVAILABLE THE DAY PRIOR TO MATURITY

ICE CEP data does not provide quotes for non-bills on trading day before maturity date.

## ZIP INSTALLS

CRSP uses a zip process for data installation. ZIP utilities that are standard on all platforms should work to unzip the databases. On Windows computers, CRSP recommends using 7-ZIP, which can be downloaded at <https://www.7-zip.org>.

## ZIP FILE STRUCTURE AND PROCESS

There are four separate zip files; each will have to be extracted separately. At the time the files are unzipped, make sure to set the directory path to the intended home directory (for example, in Windows C:\ , in Red Hat /home). The unzip process will extract to that directory under the subdirectory \crspdata.
